- Media Categories
  - Acrylics
  - Oils

  - Other Media (pencil drawing, charcoals, pen and inks, block prints, collage, encaustics)
- Original art only. Jury selections will be based on the review of the original artworks, rather than on slides or jpegs.
- Maximum frame size 20x24
- Wired for hanging with frame
  - No saw-tooth/clip hangers
- 5% contribution from artist for art sold. (Art may be marked NFS.)
- Entry fee \$25, non-refundable

*Liability: All reasonable care and safety will be exercised in the handling, hanging, and storing of the art submitted. The Friends of the Agawam Public Library, the Library, and the Town of Agawam will not be responsible for loss or damage to any item submitted.*
